Terms and Conditions:

1. The Tribal Development Department will deploy staff temporarily to operationalize the Bhawan till alternative arrangements are made.
2. The Tribal Development Department of the State Government will be the Administrative Department for the Tribal Bhawan, Bhuntar.
3. The accounts of the Tribal Bhawan Bhuntar will be auditable.
4. The Tribal people and officers/officials posted in tribal areas will get priority in the matter of reservation.

5. The Tribal people and officers/officials occupying the rooms/dormitories in the Tribal Bhawan Bhuntar shall be permitted to stay for 3 days and others for 2 days.
6. The income of the Tribal Bhawan, Bhuntar will be deposited in the Government Treasury under head 0070-other Administrative Services 60-other Services 800-other receipts.
7. For providing food, tea etc. canteen will be started on contract basis and tenders will be called through advertisement in two leading news papers and a committee constituted will finalize and approve the tenders.
8. Payment of all bills and taxes etc. will be borne by the Tribal Development Department. The contractor will pay the charges of electricity and water used by him for running the canteen in the Tribal Bhawan, Bhuntar.
9. The sanitation work of the Bhawan will be given on contract basis by inviting tenders.
10. All necessary repairs and maintenance, additional alterations and other improvement works etc. of the Tribal Bhawan, Bhuntar will be carried out by H.P.P.W.D from time to time.

The above rates/charges/terms and conditions are also applicable for newly constructed Tribal Bhawan, Chamba.


Sir,

In continuation of this department letter of even No. dated 20th February, 2008 on the subject cited above and to say that it has been decided by the Government that the management of Tribal Bhawan, Bhuntar and Chamba may be given to Public Works Department on the following terms and conditions:-

1. Tribal Bhawan, Bhuntar will be operated and maintained by Executive Engineer, HPPWD, Udaipur Division. Appropriate staff will be deployed from the existing staff of Udaipur Division and expenditure will be incurred from funds available in the non-plan for maintenance for Rest Houses in Lahaul Division.
2. On the similar lines, Tribal Bhawan, Chamba will be operated/managed by Executive Engineer, HPPWD, Bharmour Division.
3. The administrative control of the Tribal Bhawans will remain with the Tribal Development Department through Deputy Commissioner, Lahaul & Spiti for Tribal Bhawan, Bhuntar and ADM, Bharmour for Tribal Bhawan, Chamba.
4. The accounts of the Tribal Bhawan Chamba and Bhuntar will be auditable.
5. The Tribal people and officers/officials posted in tribal areas will get priority in the matter of reservations.

6. The Tribal people and officers/officials occupying the rooms/dormitories in the Tribal Bhawan Chamba and Bhuntar shall be permitted to stay for 3 days and others for 2 days.
 7. The income of the Tribal Bhawan, Chamba and Bhuntar will be deposited in the Government Treasury under Head 0070-other Administrative Services 60-Other Services 800-other receipts.
 8. Existing arrangements and procedure of reservation will continue.

Executive Engineer, PWD, Bharmaur and Udeypur are requested to take over the respective Tribal Bhawans for management immediately.




